As a reminder, NCARB is expecting to launch minor updates to the Architect Registration Examination® (ARE®) in April 2026. The changes will focus on minor adjustments to a small subset of the exam objectives outlined in the *ARE Guidelines* in order to align them with the *NCARB Competency Standard for Architects*. NCARB will also make formatting changes to the exam's case studies to improve the testing experience.

Upcoming PSI Updates for Online Testers

As of October 14, 2025, PSI will no longer support MS Windows 10 & Apple macOS Ventura for online proctored exams, as they will fall below PSI's minimum technical requirements. To avoid any disruptions, test takers will need to update their operating systems before attempting to test on or after October 14, 2025. Continuing to use unsupported systems can lead to compatibility issues and interruptions during the test session.

Online Proctoring Tip: Use a Wired Internet Connection

When you prepare for an online exam appointment with PSI, remember that you **must** connect your computer to the internet using an Ethernet cable. While Wi-Fi may work for everyday tasks, it isn't stable enough to support the technical demands of the ARE, which requires a minimum three (3) mbps of dedicated bandwidth. A wired connection offers the reliability you need to avoid disruptions during your exam—NCARB will not provide a refund or seat credit for exams disrupted due to internet connectivity issues.

To confirm your internet connection and ensure a smooth test day experience, you should be sure to <u>complete a system test run</u> **before every scheduled exam appointment**. Technical issues can arise at any time, especially with updates to your computer or testing software, or when testing in a new location.
